Emweb byba, located at Duigemhofstraat 101, 3020 Herent, Belgium, and its subsidiaries are committed to protecting your personal information and respecting your privacy.

This privacy policy documents our policies and procedures for collecting, storing, processing and disclosing your personal information. It also applies to our websites within the domains <u>emweb.be</u>, <u>webtoolkit.eu</u> and <u>genomedetective.com</u>.

Emweb only collects personal information which is reasonably necessary for its dealings with the individuals to whom the information relates. At Emweb, we are committed to maintaining the trust and confidence of our contacts and visitors to our website. In particular, we want you to know that Emweb is not in the business of selling, renting or trading email lists with other companies and businesses for marketing purposes. The types of information Emweb collects, depend on the particular dealings we have with you. We collect and hold personal information about existing and prospective customers, our third party service providers and suppliers, as well as employees and employment applicants.

Collection, Use and Sharing of the information

You can visit our websites without telling us who you are or revealing any information about yourself. Some services such as the contact form, user registrations or licensing of our software may require you to provide us with Personal Data. It may not be possible for us to provide you these services if you choose to withhold any Personal Data requested by us.

To the extent that you do provide information to Emweb, we will never sell, rent or disclose your personally identifiable information to outside parties for marketing purposes without your consent. Emweb may disclose information to third parties in order to provide our products and services to you, or related to products you have purchased from Emweb.

Your information is carefully protected both online and offline.

We collect personal data for the following purposes

- Keeping track of product licenses for licensed companies and developers: name, contact person, email address, license information
- For access to our online applications such as fora, bug tracker, blog, ...: login, email, password, name or pseudonym, and other data as entered by you. Specific applications may have an additional privacy policy, which will be clearly linked in the application.
- Communication and commercial purposes (mailings, product updates): contact information such as name, email addresses, company information, phone numbers
- Website and application analytics, and log files for monitoring the use and correct operation of our websites, market insights and service improvements
- Accounting: legally required information on suppliers and customers for proper accounting practices
- Personnel administration

When someone visits our website, we use a third party service, Google Analytics, to collect standard internet log information and details of visitor behaviour patterns. We do this to find out things such as the number of visitors to the various parts of the site. This information is only processed in a way which does not identify anyone.

Procedures in the event of a breach of security

In case of the unlikely event of a security breach, we will notify you via the email address provided within 7 days following the discovery of the breach.

Changes to this policy

As every high-quality service, our service is constantly improved to keep our users satisfied, but these improvements necessarily mean changes. Due to the on-going changes in the law and the changing nature of technology, data practices will change from time to time. Thus, Emweb reserves the right to alter or modify this Policy whenever necessary. Your privacy will not be reduced without your consent.

The provisions of this policy are in conformity with the General Data Protection Regulation (GDPR) of April 14th, 2016 in order to protect individuals with regard to the processing of personal data and on the free movement of such data.
